Categories and dues - go.eIDAS e.V. (27.09.2019)

§ 1 Membership dues

The annual contributions of the members shall be staggered according to the following table:

Category		Annual Fee
EM	Founding Member, Honorary Member, Ex-officio Member	-
EP	Natural Person	50 €
KU	Micro Enterprise (up to 20 Employees)	300 €
KMU	Small and medium-sized Enterprise (21 to 250 Emp.)	1.000 €
GU	Large Enterprise (more than 251 Emp.)	2.000 €
V	Association ¹	Barter Deal ²
HS	University or Research Organisation	300 €
BEH	Public Authority	300 €
JP	Other legal Persons	2.000 €

The Executive Board decides on deviations from the contribution rate on application in individual cases.

§ 2 Regulations

1. Contributions are generally to be paid in advance for one calendar year.
2. If a member joins the association in the course of the year, the monthly pro rata contribution of the current calendar year is to be paid at the beginning of the contribution month.
3. Membership begins upon receipt of payment of the membership fee.
4. Withdrawal from the association must be declared in writing to the executive committee at least one month in advance.
5. If membership in the association ends for any reason whatsoever, the paid membership fee will not be refunded for the current calendar year.

§ 3 Payment and Due Dates

1. Membership fees are charged every calendar year, i.e. from 1.1. to 31.12.
2. Monthly contributions are not planned.
3. The membership fee is debited from the respective current account by direct debit authorisation on 01.03. of each year, in the case of new members on the date of admission.
4. In the event of insufficient funds in the account, the accruing chargeback fee shall be borne by the member of the association. The member will be charged for any back-charge fees.

² In this case, the amount of the membership fee is determined by the membership fee of go.eIDAS e.V. in the other association.

5. Members who do not participate in the direct debit procedure shall pay their dues by 31.01. of each calendar year at the latest to the dues account of the association.

§ 4 Association Account

If the payment is not made by direct debit, the payment is permitted only on the publicly announced association account.

§ 5 Changes

1. Should the status of a member change, this member must inform the Executive Board in writing or electronically.
2. The settlement of additional payments or the reimbursement of overpaid contributions shall take place with the levying of the Membership fee for the next year.

§ 6 Validity of the Contributions Order

The contribution regulations apply from the day of the decision by the general meeting.
The contribution regulations are valid until a change is decided by the general meeting.
